MINUTES OF MEETING OF BOARD OF TRUSTEES AND BOARD OF TRUSTEES EXECUTIVE COMMITTEE OF TALLAHATCHIE GENERAL HOSPITAL

November 23, 2021

On this date at the hour of 10:30 a.m., the Board of Trustees and Board of Trustees Executive Committee met in regular session in the multipurpose room of the James C. Kennedy Wellness Center with the following trustees and personnel, to wit:

David Hargett, Trustee District One Ike Sayle, Trustee District Two Gerry Speir, Trustee District Three Morris Murphey, Trustee District Four Willie Lockett, Trustee District Five (via Zoom) Jim Blackwood, Administrator Joey Brunson, Chief Financial Officer Buddy McRae, Chief Operating Officer Rani Richard, Finance Department

Trustee Sayle opened the meeting with prayer.

The minutes of the October 26, 2021 meeting were presented. A motion was made by Trustee Hargett Sayle to approve these minutes. The motion was seconded by Trustee Sayle with all Trustees voting "Aye" in favor of the motion.

Mr. Brunson gave the Board copies of the statistics for the providers showing their production in the hospital and the clinic for the month of October 2021. The Board reviewed the statistics and questions were asked and answered.

Mr. Brunson presented the report of the Finance Committee for October 2021, financials to the Board. Questions were asked and answered about the statements. A motion was made by Trustee Sayle to approve the report of the Finance Committee as presented for October, 2020. The motion was seconded by Trustee Murphey with all Trustees voting "Aye" in favor of the motion.

Mr. Blackwood circulated the Administrator's comments, a copy of which appears as Exhibit 1 hereto and is incorporated herein by reference. Questions were asked and answered concerning the Administrator's comments.

Mr. McRae circulated the Quality Report and HCAHPS Report for October, 2021. Questions were asked and answered concerning the quality metrics for the month.

Mr. McRae next presented the Hospital Compliance Questionnaire for the FY 2021. After an explanation as to the certifications contained in this questionnaire, a motion was made by Trustee Murphey to approve this questionnaire and authorizing Trustee Speir and Mr. Blackwood to execute same. The motion was seconded by Trustee Sayle, with all Trustees voting "Aye" in favor of this motion. A copy of the Hospital Compliance Questionnaire is attached hereto as Exhibit 2.

Mr. McRae also presented two policies. The first policy was the Employee COVD-19 Vaccination Policy. After discussion of this policy, Trustee Lockett made a motion that this policy be approved. The motion was seconded by Trustee Sayle, with all Trustees voting "Aye" in favor of the policy. The second policy was the Employee COVID-19 Vaccination Exemption Policy. After a discussion as to the exemptions, Trustee Sayle made a motion that this policy be approved. The motion was seconded by Trustee Murphey, with all Trustees voting "Aye" in favor of the policy.

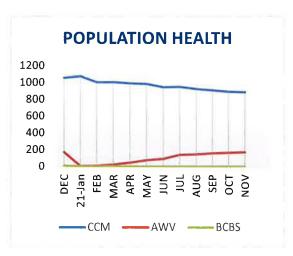
Mr. Blackwood stated that it was time to elect officers for Fiscal Year 2022. Trustee Hargett moved that the president and secretary stand for re-election for Fiscal Year 2021. The motion was seconded by Trustee Murphey, with all Trustees voting "Aye" in favor of the motion.

There being no further matters for discussion, the Board adjourned.

Administrator's Comments – Meeting of November 23, 2021

Nursing Home Census: We have 72 residents in the nursing home, down from 73 last month, due to a death. We have 13 beds open on the general care side and 12 on the special care side. We currently have 4 referrals whose admissions are being reviewed.

ACO and **Population** Health **Initiatives**: We have 887 participants enrolled in our Chronic Care Management program. Open enrollment is officially underway again, and we are encouraging current and former participants to retain their traditional Medicare plans. We have now conducted 171 Medicare Annual Wellness Visits, up from 165 last month. BCBS Color Me Healthy exams remain flat.



TGH Discount Pharmacy: We filled 4,607 prescriptions in October, down slightly from 4,663 prescriptions in September.

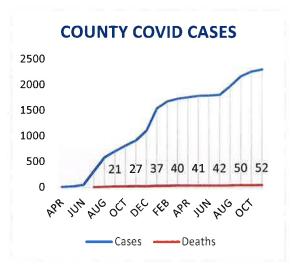
COVID-19: Tallahatchie County's number of COVID-19 cases increased to 2,308, up from 2,268 last



month. There was one additional death last month, bringing the county's total number of COVID-19 deaths to 52

We currently have no positive ECF residents, and no positive patients on the hospital floor. Outbreaks among staff remain relatively rare.

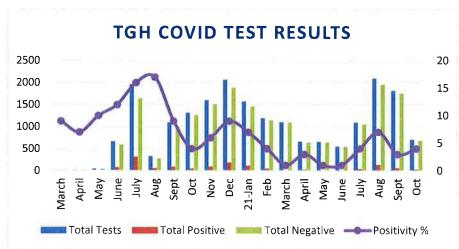
Demand for the vaccine at the clinic remains relatively low, but steady. We are providing 10-20 new vaccinations per week; however, we have seen a significant increase in demand for booster shots. We have ordered the newly-available pediatric vaccine



from Pfizer, which may be given to children 5 and older.

CMS Vaccine Mandate: The Centers for Medicare and Medicaid Services has announced a new rule requiring all employees of healthcare facilities participating in Medicare or Medicaid to be vaccinated against Covid-19. The rule requires facilities to have policies in place by December 6 requiring employee vaccinations, and for all employees to be fully vaccinated by January 5, 2022. We have drafted the required policies and will be presenting them for board action today.

There are only two possible exemptions. which are for medical and religious reasons. but these exceptions are very narrow. The rule



requires us to have processes to handle these requests, and in keeping with the policy I have appointed a committee that will decide them. Since the rule was announced, we have stressed to our staff that, since virtually all medical employers participate in Medicare or Medicaid, it will be difficult for any professional staff to find employment elsewhere. We also obtained 100 doses of the Johnson & Johnson vaccine, since it requires one dose and does not use Messenger RNA (which some find objectionable) found in other vaccines. We have asked our non-vaccinated employees to let us know their intentions so that we can begin looking for any needed replacements. I am encouraged by the early response, as many are now indicating that they will be take the vaccine.

ECF Courtyard Project: I have been told by the Foundation that the plans for the courtyard project are now complete, and that funding is in place. My understanding is that construction will hopefully begin in the spring.

DNV Site Visit: Our DNV inspection has still not taken place, and is now somewhat later than usual.

Tutwiler Clinic: I have been told that the Foundation is still working to secure a suitable site to build a new Tutwiler Clinic building. My understanding is that negotiations are ongoing.

Legal Matters – Victoria Sturdivant: We have been served with process, and have filed a responsive pleading.
